The best results are obtained by comparing the price, costs, speed, probability of execution and settlement, size, nature and other matters relevant to execution of the order. The weighting of these parameters will vary but typical price and speed are pivotal. In the case of a large order; the company may attach greater importance to other factors, if the order is expected to suffer a significant price impact or impact the probability of the expedition of the order.
